This spring members of the ETFO Upper Canada Local will elect our Executive (President, Vice- Presidents and non-released Executive members) for the 2025-2027 term. Once again, we will be conducting an online vote.

FAQ

Q: Who can run for these elected positions?

A: You can! Any member in good standing can hold a position on the Executive.

Q: Why should I consider running?

A: Becoming an elected member of the Executive is a great opportunity for personal and professional growth. It is also the best way to learn how the local unit of your federation interacts with the Board and management, and how it strives to protect your rights, improve your working conditions and offer professional development opportunities.

Q: What if I decide to run after the April 15th deadline? A: Nomination forms will be accepted at the Local office until April 15th for Executive and April 15th for Annual Meeting Delegates. Nomination forms can also be submitted when called for from the floor during the Annual General Meeting on April 16th, however, your campaign materials will have missed the March 17th deadline to be included in this bulletin or posted on the website, so your election campaign will be limited.


